Acting Chief Woestman updated the Commission on Covid related issues within the department. Acting Chief Woestman announced that Daniel McDevitt from P4 Security Solutions /REM Management Services was present to give a presentation regarding the rewriting of the department SOPs.

Acting Chief Woestman stated the Police department was awarded \$7000 by the Crown Point Community Foundation Grant for the incorporation of a bike patrol unit and advanced defensive tactics training. This training will be contracted through Corral's Martial Arts who are starting a program for law enforcement only.

Acting Chief Woestman reviewed the Statistics for 2020.

Commissioner Patterson asked if officers were getting the Covid vaccine. Acting Chief Woestman

stated about 5 officers have and others are still undecided or moving toward it.
