REGULAR MEETING March 10, 2025

The regular meeting of the Lowell Town Council was called to order on Monday, March 10, 2025, at 7:00 P.M. by Council President Todd Angerman. The Pledge of Allegiance was recited followed by a moment of silence. Clerk-Treasurer Jill Murr called the roll. The members present were Todd Angerman, Mike Gruszka, John Alessia, Shane Tucker, and John Yelkich. Staff present were Assistant Police Chief Bob Hornickel, Town Manager Craig Hendrix, GIS Director Greg White, and Town Attorney David Westland.

APPROVAL OF MINUTES

Councilman Gruszka made a motion to approve the February 24, 2025, Work Session and Regular meeting minutes, seconded by Councilman Yelkich and carried with five ayes on voice vote.

APPROVAL OF TREASURER'S REPORT

Councilman Tucker made a motion to approve the February 2025 Treasurer's Report, seconded by Councilman Yelkich; motion carried with five ayes on voice vote.

APPROVAL OF VOUCHERS

President Angerman stated he reviewed the vouchers. White Vouchers #13257 – 13317 \$905,005.38; White – Police #1394 – 1403 \$7,991.54; Wastewater #6174 – 6205 \$182,332.35; and Stormwater Utility #6449 – 6457 \$19,738.41. Petition for Disannexation - JCB Companies - John Brill - Public Hearing

Attorney Adam Sworden presented the petition for disannexation for the property commonly known as Redwing Lakes Subdivision. The developer has had a lack of response from Indiana American Water for a water line. The developer does not have the ability to obtain an easement; he can't exercise eminent domain. The petition is for disannexation so that the developer may go to Lake County and get wells to this location. Councilman Angerman opened the public hearing. There being no comments in person or online, Councilman Angerman closed the public hearing. Motion by Councilman Yelkich and seconded by Councilman Alessia to approve JCB Companies petition for disannexation; motion carried with five ayes on roll call vote.

Motion by Councilman Yelkich and seconded by Councilman Alessia to put the rules back in order; motion carried with five ayes on voice vote.

Clerk-Treasurer Murr presented Resolution No. 2025-01 – Dormant Fund. The Water Utility Operating Fund #6101 has been dormant. This will allow the \$91,477.95 in the Water Utility Fund to be closed out and transferred to the General Fund. Motion by Councilman Alessia and seconded by Councilman Yelkich to approve Resolution No. 2025-01 – Dormant Fund; motion carried with five ayes on roll call vote.
