The next Police Commission meeting was scheduled for Thursday, June 26th, 2025 beginning at 7 pm.

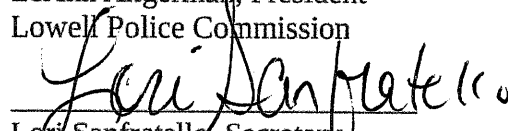
XII. ADJOURNMENT
