There was none.

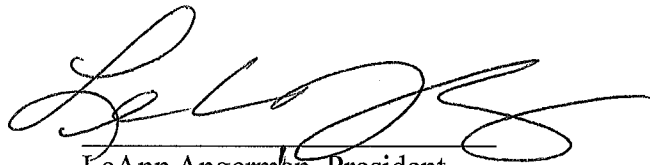
X. ANNOUNCEMENTS

The next Police Commission meeting was set for July 24, 2025, at 7:00 pm.

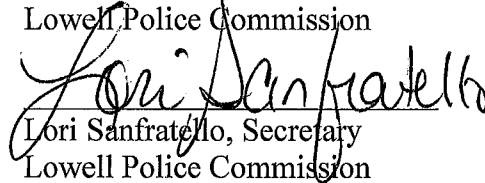
XI. ADJOURNMENT
