TOWN OF LOWELL POOL PERMIT INFORMATION

Permit Application Time-frame: Permits are issued within 10 business days if information is provided in a timely manner.

Permit Requirements for All Pools:

- Pool permit package filled out, signed and notarized*
- Affidavit filled out by homeowner or contractor, signed and notarized*
- *Survey showing the dimensions of the pool and where the pool will be located on the property. Pool must be:
 - At least ten feet from the house
 - Comply with zoning setbacks
 - NOT located in an easement
- Photograph of the type of pool to be installed

Underground Pools:

- *All of the above plus a completed erosion and sediment control package, signed and notarized* Construction Requirements for All Pools:
- Pool barrier is required:
 - Top of pool sides must be at least four feet above ground all around the pool OR
 - A fence at least four feet high enclosing the yard or pool area is required OR
 - Pool barrier must be installed on the sides of the pool so that the height of the barrier is at least four feet above grade all around the pool.
- *All work must conform to the Lowell Building and Zoning Ordinance, the State Indiana Pool Code and the Indiana Electrical Code. These can be found in the 2020 Indiana Residential Code, Chapter 3, Section R326, and Chapter 42 and the applicable Town of Lowell Ordinances.
- *Unless done by the homeowner, electrical work must be performed by an electrician registered in the Town of Lowell.

Inspection Requirements for all Pools: Inspections must be requested at least 24 hours prior to the desired inspection date. Inspections are conducted on Mondays, Wednesdays and Thursdays. All mechanical and safety equipment must be in place and operational at the time of the final inspection.

- •Minimum inspections needed:
 - Underground electric
 - Final electric (Must be passed before a final pool inspection can be scheduled.)

Gas Heater

If a gas heater is to be installed the following inspections are also required for all pool types:

- Underground Gas
- Final Gas
- Pool mechanicals (filter, etc.) must be in operation AT THE TIME of the final inspections.
- *Pool and electrical work must pass all final inspections prior to the use of the pool.
- Minimum Inspections needed:

Underground electric

- Underground Plumbing

- Pre-Pour Footing

Pre-Pour Deck

- Light Bonding - Pool Bonding

Final Plumbing

- Final Electric

- Pool Final
