Chief Woestman stated the policy revisions are with the attorney and he will get them on the agenda once they are approved.

Chief Woestman announced 2 officers are scheduled to attend the School Resource Officer training course to work part time in the schools for this year and he hopes to have 6 officers working in the schools by the end of the year.

Chief Woestman informed the Commission active shooter training was completed last month. Chief Woestman stated the Lowell Police Department has signed a Memorandum of Understanding with the Crown Point, Cedar Lake, Dyer, Saint John, and Schererville Police Departments to form a team to respond to serious bodily injury and fatal accidents. The sheriff's department no longer assists other agencies with reconstruction.
