HISTORIC: #18-028 – 407 E. Commercial PETITONER: Tracey O'Brien

### CERTIFICATE OF APPROPRIATENESS PURPOSE:

**Exterior Painting** 

Mr. Bytnar discussed the Town's guidelines for aesthetics. He noted there is a lot of leeway for the Board. The criteria would be in making sure that the color doesn't negatively affect any of the surrounding properties or devalue the property itself. He stated from a color standpoint there is nothing in the guidelines that specifically say anything one way or another and it is more in keeping with the time the property was originally developed. Discussion followed.

Mrs. O'Brien stated she had updated her color choices since she had made application to the Board and showed the new color swatches. She stated that the specific colors are Gray Screen for the building, Software for the trim and Plum Dandy for the signage. Mrs. O'Brien noted that the door would also be the Plum Dandy color. Discussion followed on the awning color.

#### CERTIFICATE OF APPROPRIATENESS PURPOSE:

Signage

Mr. Kinnis asked if the sign size was staying the same. Mrs. O'Brien stated yes. Mr. Bytnar stated that he would request there be some trim around the sign, same color as the lettering. He noted it looks historically more appropriate. Mr. Bytnar stated that the petitioner will need to apply for a sign permit through the building department. He noted that this is a certificate of appropriateness it is not an actual approval for the signage. Mr. Bytnar stated this is for historical appropriateness only, this Board has no jurisdiction over the sign ordinance.
