NEW BUSINESS:

PC #19-003 – **Heritage Falls Phase 4 -** application to request a zone change from R2 single family to R3 two family. Petition has been filed by Providence Homes at Regency Inc, 700 Springer Dr. Lombard, IL 60148. This is for property located at approx. partial northwest corner of 173rd Ave. and Cline Ave., in the Heritage Falls Subdivision, Parcel # 45-19-15-451-001.000-038.

Mr. Sheridan stated per direction of the Town's legal counsel he is asking for a motion to open the public hearing.

On behalf of the above-designated entities, we hereby withdraw our Peition for a change of zone from R2-R3 for the approximately thirty-two (32) acres of undeveloped property in Heritage Falls Subdivison. Please remove us from the Plan Commission Agenda as we have formally withdrawn our petition.

Mr. Sheridan stated that he is suggesting per direction of legal counsel to call for a motion to close the public hearing.

Mr. Farellbegg made a motion to close the public hearing, seconded by Mr. Salatas and carried with a voice vote of all ayes.

PC 19-004 – ZONING ORDIANCE UPDATES

Amendments to Chapter 155: Land use and development code; subdivision code: To

update, but not limited to, basic provisions, zoning districts, land use matrix, development standards, sign standards, site design standards, nonconforming structures, lots, and uses, subdivision control code, and site plan review.
