A general scope/description of the Project is as follows:

Pavement and subbase replacement to the bottom of curb. All proposed streets are currently curbed. Roadway will be replaced with 1.5 inches of surface, 3 inches of intermediate or base, 5 inches of compacted aggregate atop geotextile fabric and grid. Minor curb and drive approach replacement is anticipated. Sidewalk ramps within the project area requiring update will be replaced to meet current ADA standards.
