GENERAL PROVISIONS

' 70.01 DEFINITIONS.

For the purpose of this title, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

ALLEY. Highway of less than 24 feet total width. ('80 Code, ' 10.04.010) (Ord. 6-1968, passed - -68)

AUTHORIZED EMERGENCY VEHICLE.

- (1) The following vehicles:

- (a) Fire department vehicles,
- (b) Police department vehicles;
- (c) Ambulances;
- (d) Emergency vehicles operated by or for hospitals or health and hospital corporations under IC 16-22-8.

(2) Vehicles designated as emergency vehicles under the Indiana Department of Transportation under IC 9-21-20-1.

(3) Motors vehicle that, subject to IC 9-21-20-2, are approved by the Indiana Emergency Medical Services Commission that are:

(a) Ambulances that are owned by persons, firms, limited liability companies, or corporations other than hospitals; or

(b) Not ambulances and that provide emergency medical services, including extrication and rescue services (as defined in IC 16-18-2-110).

(4) Vehicles of the Department of Correction that, subject to IC 9-21-20-3, are:

(a) Designated by the Department of Correction as emergency vehicles; and

(b) Responding to an emergency. (IC 9-13-2-6)

BUSINESS DISTRICT. The territory contiguous to and including a highway when at least 50% of the frontage of the territory for a distance of at least 500 feet is occupied by buildings in use for business. (IC 9-13-2-18)

CLASS 1 ELECTRIC BICYCLE. An electric bicycle equipped with an electric motor that:

- (1) Provides assistance only when the

operator is pedaling; and

(2) Ceases to provide assistance to the operator when the electric bicycle reaches a speed of 20 miles per hour.
(IC 9-13-2-26.6)

CLASS 2 ELECTRIC BICYCLE. An electric bicycle equipped with an electric motor that:

(1) May be used to exclusively propel the electric bicycle; and

(2) Ceases or is unable to provide assistance when the bicycle reaches a speed of 20 miles per hour.
(IC 9-13-2-26.7)

CLASS 3 ELECTRIC BICYCLE. An electric bicycle equipped with an electric motor that:

(1) Provides assistance only when the operator is pedaling; and

(2) Ceases to provide assistance when the bicycle reaches a speed of 28 miles per hour.
(IC 9-13-2-26.8)

CLASS A MOTOR DRIVEN CYCLE. A motor vehicle that:

(1) Has a seat or saddle for the use of the rider;

(2) Is designed to travel on not more than three wheels in contact with the ground;

(3) Complies with applicable motor vehicle equipment requirements under IC 9-19 and 49 C.F.R. 571; and

(4) Is registered as a Class A motor driven cycle under IC 9-18 (before its expiration) or IC 9-18.1.

The term does not include an electric personal assistive mobility device or an electric bicycle.
(IC 9-13-2-25.8)

CLASS B MOTOR DRIVEN CYCLE. A motor vehicle that:

(1) Has a seat or saddle for the use of the rider;

(2) Is designed to travel on not more than three wheels in contact with the ground;

(3) Complies with applicable motor vehicle equipment requirements under IC 9-19 and 49 C.F.R. 571;

(4) Has a cylinder capacity not exceeding 50 cubic centimeters; and

(5) Is registered as a Class B motor driven cycle under IC 9-18 (before its expiration) or IC 9-18.1.

The term does not include an electric personal assistive mobility device or an electric bicycle.
(IC 9-13-2-26.5)

CROSSWALK. Any of the following:

(1) That part of a roadway at an intersection included within the connections of the lateral lines of the sidewalks on opposite sides of the highway measured from the curbs, or in the absence of curbs, from the edges of the traversable roadway.

(2) A part of the roadway distinctly indicated for pedestrian crossing by lines or other markings on the surface.
(IC 9-13-2-40)

DRIVER. Any person who is in actual physical control of a vehicle. ('80 Code, ' 10.04.030) (Ord. 6-1968, passed - -68)

ELECTRIC BICYCLE. Any bicycle that:

(1) Is equipped with:

(a) Fully operable pedals;

(b) An assistive, electric motor with a power output not greater than 750 watts; and

(2) Meets the requirements of a Class 1, Class 2, or Class 3 electric bicycle.
(IC 9-13-2-49.2)

EMERGENCY VEHICLE. Vehicles of the Police or Fire Departments, ambulances, or any vehicle conveying a town official or employee in response to an emergency official call. ('80 Code, ' 10.04.040) (Ord. -1969, passed - -69)

INTERSECTION. The area embraced within:

(1) The prolongation or connection of the lateral curb lines, or if none, then the lateral boundary lines of the roadways of two highways that join at, or approximately at, right angles; or

(2) The area within which vehicles traveling upon different highways joining at any other angle may come in conflict.
(IC 9-13-2-84)

MOTOR VEHICLE. Except as otherwise provided in this chapter, a vehicle that is self-propelled. The term does not include a farm tractor, an implement of agriculture designed to be operated primarily in a farm field or on farm premises, an electric bicycle, an electric foot scooter, or an electric personal assistive mobility device. (IC 9-13-2-105)

MOTORCYCLE. A motor vehicle with motive power that:

(1) Has a seat or saddle for the use of the rider;

(2) Is designed to travel on not more than three wheels in contact with the ground; and

(3) Satisfies the operational equipment specifications described in 49 C.F.R. 571 and IC 9-19.

The term does not include a farm tractor, an electric bicycle, or a motor driven cycle. (IC 9-13-2-108)

PARK. To stand a vehicle, whether occupied or not, for a period of time greater than is reasonably necessary for actual loading or unloading of persons or materials. ('80 Code, ' 10.04.090) (Ord. 6-1965, passed - -65)

PROPERTY LINE. The line marking the boundary between any street and the lots or property abutting thereon. ('80 Code, ' 10.04.120) (Ord. 6-1961, passed - -61)

ROAD TRACTOR. Every motor vehicle designed and used for drawing other vehicles and not so constructed as to carry either any load thereon independently or any part of the weight of a vehicle or load so drawn. ('80 Code, ' 10.04.130) (Ord. 9-1961, passed - -61)

ROADWAY. The part of a highway improved, designed, or ordinarily used for vehicular travel. (IC 9-13-2-157)

SEMI-TRAILER. A vehicle without motive power designed for carrying property and for being drawn by a motor vehicle, and so constructed that some part of the weight of the semi-trailer and that of the semi-trailer's load rests upon or is carried by another vehicle. The term does not include the following:

(1) A pole trailer.

(2) A two-wheeled homemade trailer.

(3) A semi-trailer used exclusively for carrying passengers, such as a bus.

SIDEWALK. The part of a street between the curblines and the adjacent property lines intended for the use of pedestrians. (IC 9-13-2-167)

SKATEBOARD. Any non-motorized instrument, used to transport person(s) by means of wheels, rollers, and the like propelled solely by the force of its rider and shall not include any wagon, bicycle or other device not so propelled. ('80 Code, ' 10.04.165) (Ord. 1989-15, passed - -89)

STREET or HIGHWAY. The entire width between the boundary lines of every way publicly maintained when any part of the way is opened to the use of the public for purposes of vehicular travel. (IC 9-13-2-175)

TRAFFIC. Pedestrians, ridden or herded animals, vehicles, and other conveyances either singly or together while using any highway for purposes of

travel. (IC 9-13-2-182)

TRAILER. Every vehicle without motive power designed for carrying passengers or property and for being drawn by a motor vehicle and so constructed that no part of its weight rests upon the towing vehicle. ('80 Code, ' 10.04.190) (Ord. 6-1968, passed - -68)

TRUCK. Every motor vehicle designed, used or maintained primarily for the transportation of property which is classified over one ton. ('80 Code, ' 10.04.195) (Ord. 6-1968, passed - -68)

TRUCK TRACTOR. Every motor vehicle designed and used primarily for drawing other vehicles and not so constructed as to carry a load other than a part of the weight of the vehicle and load so drawn. ('80 Code, ' 10.04.200) (Ord. 6-1968, passed - -68)

VEHICLE. A device in, upon or by which a person or property is, or may be, transported or drawn upon a highway. The term refers to an automobile, a motorcycle, a truck, a trailer, a semi-trailer, a tractor, a bus, a school bus, a recreational vehicle, or a motorized bicycle.

' 70.04 **RIGHT-OF-WAY OF EMERGENCY VEHICLES.**

(A) *Yielding right of way to authorized emergency vehicles with siren or flashing lights.*

(1) Upon the immediate approach of an authorized emergency vehicle, when the person who drives the authorized emergency vehicle is giving audible signal by siren or displaying alternately flashing red, red and white, or red and blue lights, a person who drives another vehicle shall do the following unless otherwise directed by a law enforcement officer:

(a) Yield the right of way.

(b) Immediately drive to a position parallel to and as close as possible to the right hand edge or curb of the highway clear of any intersection.

(c) Stop and remain in the position until the authorized emergency vehicle has passed.

(2) This section does not operate to relieve the person who drives an authorized emergency vehicle from the duty to drive with due regard for the safety of all persons using the highway. (IC 9-21-8-35(a), (d))

(B) *Prohibition against following fire apparatus responding to fire alarm or parking within block where apparatus has stopped in response to alarm.* A person who drives a vehicle that is not on official business may not do any of the following:

(1) Follow any fire apparatus traveling in response to a fire alarm at a distance closer than 500 feet.

(2) Drive into or park a vehicle within the block where fire apparatus has stopped in answer to a fire alarm.

' 70.05 ACCIDENT REPORT; FEE FOR COPIES; ACCOUNT.

Upon proper demand by a person or the authorized agent or attorney of a person entitled to receive a copy of the investigator's report of a motor vehicle accident pursuant to IC 9-26-2, the Police Department shall be allowed to charge and collect a fee in an amount set by Council for each report. Such fees shall be deposited with the Clerk-Treasurer in a separate account to be known as the AAccident Report Account@ and may be expended at the discretion of the Chief of Police for any purpose reasonably related to the keeping of accident reports and records or the prevention of street and highway accidents.

VEHICLE INSPECTION FEES

' 70.15 INSPECTION FEE.

A vehicle inspection fee shall be assessed in an amount set by Council for each certificate of title application vehicle inspection performed by an officer of the Police Department as defined in IC 9-17-2-12. ('80 Code, ' 10.48.010) (Ord. 1988-15, passed 6-27-88)

' 70.16 COLLECTION PROCEDURE.

The following procedure shall be followed with respect to each vehicle inspection fee collected:

(A) A receipt for each inspection fee received shall be issued by the Police Department on a form prescribed by the State Board of accounts.

(B) Receipts shall be remitted to the Town Clerk-Treasurer at least once every seven days.

(C) The Town Clerk-Treasurer shall establish a fund separate and apart from the general fund to hold, invest and disburse the fee receipts which fund shall be designated as the vehicle inspection fund. ('80 Code, ' 10.48.020) (Ord. 1988-15, passed 6-27-88)

' 70.17 DESIGNATED EXPENDITURES FROM VEHICLE INSPECTION FUND.

Expenditures from the vehicle inspection fund as established by this chapter shall be appropriated by the Town Council only for law enforcement purposes such as the following:

(A) Police Department vehicle repairs and replacement.

(B) Police Department radio equipment repairs and replacement.

(C) Police Department officer and designated Police Department employees education and training. ('80 Code, ' 10.48.030) (Ord. 1988-15, passed 6-27-88)

' 70.18 CLAIMS; MANNER OF PROCESSING.

All expenditures from this designated fund shall be appropriated and processed in the same manner as all

other claims against the town.

‘ 70.99 PENALTY.

Any person who violates any provision of this traffic code for which no penalty is otherwise provided shall be subject to a penalty of a fine of not more than an amount set by Town Council and subject to amendment by Council from time to time. The current penalty is available for public inspection in the town offices during normal business hours. Each person shall be guilty of a separate offense for each and every day during any portion of which any violation of a provision of the traffic code is committed, continued or permitted by such person.

GENERAL PROVISIONS

' 71.01 ONE-WAY TRAFFIC.

The Town Board of Highways may designate any highway or any separate roadway under its jurisdiction for one-way traffic and shall erect appropriate signs giving notice thereof. Upon a roadway designated and sign-posted for one-way traffic, a vehicle shall be driven only in the direction designated.

' 71.02 SIGN ERECTION.

Appropriate signs indicating the direction of lawful traffic movement shall be placed at every intersection where movement of traffic in the opposite direction is prohibited.

' 71.03 ANIMALS AND BICYCLES.

Every person riding a bicycle or an animal, or driving an animal drawing a vehicle upon any street shall be subject to the provisions of this title applicable to the driver of a vehicle, except those provisions which can have no application to one riding a bicycle or driving an animal.

' 71.04 EXEMPTIONS.

The provisions of this chapter regulating the movement of vehicles shall not apply to emergency vehicles while the driver thereof is engaged in the performance of emergency duties nor shall such provisions apply to persons actually engaged in repairing or otherwise improving the alley or roadway under the authority of the Town Council.

' 71.05 SPEED LIMIT.

(A) Whenever local authorities in their respective jurisdictions determines that the maximum speed permitted under this chapter is greater or less than reasonable and safe under the conditions found to exist on a highway or part of a highway, the local authority may determine and declare a reasonable and safe maximum limit thereon.
(IC 9-21-5-6(a)) ('80 Code, ' 10.08.010)

(B) No person shall drive a vehicle upon any public highway in the town at a speed greater than is reasonable and proper having regard for the traffic and the use of the way or so as to endanger the life or limb or injure the property of any person.
('80 Code, ' 10.08.020) Penalty, see ' 71.99

' 71.06 STOP OR YIELD SIGNS, INCLUDING AUTOMATIC SIGNAL TRAFFIC CONTROL DEVICES; DUTY TO OBEY.

(A) A person who drives a vehicle shall do the following:

(1) Stop as required under this section at the entrance to a through highway.

(2) Yield the right of way to other vehicles that have entered the intersection from the through highway or that are approaching so closely on the through highway as to constitute an immediate hazard.

(B) After yielding as described in division (A) (2), the person who drives a vehicle may proceed and persons who drive other vehicles approaching the intersection on a through highway shall yield the right of way to the vehicle proceeding into or across the through highway.

' 71.07 STOPPING OF VEHICLE AT ENTRANCES TO THROUGH HIGHWAY WHERE A STOP SIGN OR AUTOMATIC SIGNAL TRAFFIC CONTROL DEVICE ERECTED.

A person who drives a vehicle shall stop at an intersection where a stop sign or an automatic signal traffic control device is erected at one or more entrances to a through highway that are not a part of the through highway and proceed cautiously, yielding to vehicles that are not required to stop.

' 71.08 DRIVING PROCEDURE IN APPROACHING YIELD SIGN; RIGHT OF WAY OF PEDESTRIAN LEGALLY CROSSING ROADWAY.

(A) A person who drives a vehicle approaching a yield sign shall slow down to a speed reasonable for the existing conditions or stop if necessary. The person shall yield the right of way to a pedestrian legally crossing the roadway and to a vehicle in the intersection or approaching on another highway so closely as to present an immediate hazard. After yielding, the person may proceed, and all other vehicles approaching the intersection shall yield to the vehicle proceeding.

(B) If a person who drives a vehicle is involved in a collision with a pedestrian in a crosswalk or a vehicle in the intersection after driving past the yield sign without stopping, the collision is considered prima facie evidence of the person's failure to yield the right of way.

' 71.09 ENTERING, LEAVING OR CROSSING ROADWAY.

(A) A person who drives a vehicle that is about to enter or cross a roadway from any alleyway, driveway or parking lot shall yield the right-of-way to all vehicles approaching on the roadway.

(B) The operator of every vehicle along a roadway approaching an intersection shall not leave the traveled portion of the roadway or operate a vehicle against or over a curb when make a right or left turn and the operator of any vehicle approaching an intersection shall not cross, or attempt to cross, any public or private property to avoid any traffic control device or signal at any intersection.

' 71.10 YIELDING TO PEDESTRIANS IN CROSSWALK.

When traffic control signals are not in place or not in operation, a person who drives a vehicle shall yield the right of way, slowing down or stopping if necessary to yield, to a pedestrian crossing the roadway within a crosswalk when the pedestrian is upon the half of the roadway upon which the vehicle is traveling or when the pedestrian is approaching closely from the opposite half of the roadway.

' 71.11 VEHICLE MAKING LEFT TURN TO YIELD RIGHT OF WAY TO VEHICLES APPROACHING FROM OPPOSITE DIRECTION.

A person who drives a vehicle within an intersection intending to turn to the left shall yield the right of way to a vehicle approaching from the opposite direction that is within the intersection or so close to the intersection as to constitute an immediate hazard. After yielding and giving a signal as required by this chapter, the person who drives the vehicle may make the left turn, and the persons who drive other vehicles approaching the intersection from the opposite direction shall yield the right of way to the vehicle making the left turn.

' 71.12 PEDESTRIAN REGULATIONS.

(A) Pedestrians must cross any highway, roadway, alley or street only in designated crosswalks or at intersections. Pedestrians may not cross any highway, roadway, alley or street at an intersection where the traffic is controlled by any automatic signal traffic control device when the vehicular traffic has the right-of-way. Pedestrian traffic should only cross at intersections controlled by other regulatory signs when safe to do so or when traffic is stopped.

(B) Pedestrians shall obey the instructions of an official traffic control device specifically applicable to the pedestrian, unless otherwise directed by a police officer.

(C) Pedestrian traffic must cross all highways, roadways, alleys or streets walking perpendicular to the roadway in the most direct route across all traffic lanes. Pedestrians must walk on the right side of any crosswalk and proceed at a reasonable pace as to not purposefully hinder the flow of other pedestrians or vehicular traffic.

(D) Any violation of IC 9-21-17 shall also be a violation of this section.

' 71.13 JAKE BRAKES; USE PROHIBITED.

(A) *Definition. JAKE BRAKES.* Any dynamic braking device (commonly referred to as jake brakes, jacobs brakes, engine brakes or compression brakes) used primarily on trucks for the conversion of the engine from an internal combustion engine to an air compressor for the purpose of braking a vehicle without the use of wheel brakes.

(B) *Use prohibited.* It is unlawful for any person to operate any motor vehicle with a jake or dynamic braking device engaged with the town limits.

(C) *Penalty.* Each violation of this section shall, in addition to any other penalty that may be applicable, subject the operator of said vehicle to a fine of not less than \$100 nor more than \$1,000 for each such violation.

(D) *Posting signs.* The Director of Public Works is authorized and directed to post appropriate signs consistent with the provisions of this section.

' 71.14 VEHICLE WINDOWS.

No person shall operate any vehicle that has its windows covered or treated with any substance or material that would obscure the vision of the driver of said vehicle or that prevents any occupant or the interior of said vehicle from being readily seen by a person outside of the vehicle, however, this section shall not apply to any vehicle that may have its windows treated or covered in compliance with any state or federal law, rule or regulation regarding window treatment or coverings.

' 71.15 UNSAFE OPERATION OF VEHICLE.

It shall be a violation of this chapter for the operator of any vehicle to:

(A) Engage or attempt to engage others in a race or speed contest with any other vehicle or person unless said race or contest is authorized under state or local law in an area approved for racing or speed contests;

(B) Accelerate, stop or operate a vehicle in such a manner that would distract or avert the attention of the operator of any other vehicle or that would harm, damage or deface, or threaten to harm, damage or deface, any person or property or the surface of any roadway or property, except when such action is reasonably necessary to avoid a collision with any other vehicle or person;

(C) Overtake or pass another vehicle in an unsafe manner or by leaving the traveled portion of the roadway in any manner;

(D) Intentionally or recklessly operate a vehicle to threaten harm or damage to any person or property; or

(E) Move or operate any vehicle when the movement of said vehicle will cause any person to be pulled, dragged or towed by said vehicle on any public road or way.

TRUCK TRAFFIC

' 71.15 TRUCKS RESTRICTED.

(A) No driver of a road tractor, semi-trailer, trailer or truck tractor shall drive it upon any street (not listed in Chapter 74, Sched. IV as a truck route or within a residential area) except for the purpose of making a delivery or carrying on business in the block in which such vehicle is being driven. Any driver making such delivery shall enter the street at the first intersection nearest the point of delivery and leave such street at the first intersection after such delivery.

(B) It is the intent of this section that any driver making such delivery or carrying on business on a street other than a truck route shall use the shortest possible route to and from a truck route for purposes of making the delivery or carrying on the business.

VEHICLE WEIGHT RESTRICTIONS**' 71.30 WEIGHT LIMITATION ON POSTED STREETS; PERMIT REQUIRED FOR LAWFUL OPERATION.**

(A) It shall be unlawful for any person to operate, move or permit to be operated or moved upon any street within the town, which street may hereafter be posted by the Town Council, any vehicle or combination of vehicles of a weight exceeding the total gross weight, with load of 14,000 pounds.

REGULATION OF TRAFFIC ON TRI-CREEK SCHOOL GROUNDS**' 71.45 DEFINITIONS.**

For the purpose of this chapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

SCHOOL GROUNDS. All real property which is owned or controlled by the Tri-Creek School Corporation, which is located within the boundaries of the town and surrounds or is adjacent to any school corporation building.

VEHICLE. Except as otherwise may be provided in this chapter, any device in, upon, or by which a person or property is, or may be transported or moved upon school grounds.
(Ord. 1995-6, passed 6-26-95)

' 71.46 VEHICLE AND TRAFFIC REGULATIONS.

(A) No vehicle shall be driven upon school grounds at a speed greater than 10 miles per hour.

(B) No vehicle shall accelerate in such a manner as to deliberately cause the tires to spin and lose traction upon the paved surfaces of the school grounds.

(C) No vehicle, with the exception of invalid chairs, school maintenance or administrative vehicles, school district coach's vehicles, or emergency vehicles

may be driven upon the unpaved areas of any school corporation grounds.

(D) The use of all terrain vehicles (ATV), snowmobiles, skateboards, mini-bikes, go-carts, roller skates, roller blades, golf carts, or other such vehicles, is prohibited on both the paved and unpaved areas of any school corporation grounds.

(E) The use of wagons, buggies, or other conveyances which may be drawn by horses or ponies, on school corporation without permission from the school administration is prohibited.

(F) All service delivery vehicles must turn off their engines while making deliveries to school buildings.

(G) Parents, guardians, students and other visitors are prohibited from idling vehicles on school grounds for a period of time exceeding five minutes. (Ord. 1995-6, passed 6-26-95; Am. Ord. 2012-06, passed 5-29-12)

' 71.47 ENFORCEMENT AND PENALTIES.

(A) The regulations specified herein are considered infractions and may be enforced by the Police Department in the same manner as any other traffic ordinance adopted by the town.

(B) An officer of the Lowell Police Department may issue a citation for violation of these traffic regulations witnessed by an employee of the Tri-Creek School Corporation, provided that the employee signs the citation below the name of the issuing officer and agrees to appear in court with the officer if the citation is contested.

(C) Violations of these traffic regulations shall be punishable as provided in Chapter 10.

(D) This section of the traffic code shall not be enforceable until signs giving notice of the traffic regulations are posted upon or at the entrance or entrances to the school corporation properties affected. The expenses incurred for the posting of regulatory signs as required by law shall be the responsibility of the Tri-Creek School Corporation. This chapter will be enforceable after two publications in the local paper. (Ord. 1995-6, passed 6-26-95)

' 72.01 REGULATION OF MUNICIPAL PARKING LOTS; PARKING PERMITS.

The regulation of the municipal parking lots designated by the Town Council shall be regulated as follows:

(A) *Supervision.* The municipal parking lots now or hereafter acquired or established by the town shall be under the supervision of the Chief of Police.

(B) *Use.* It shall be unlawful to park any vehicle in any municipal parking lot in violation of this code or any other applicable ordinance of the town or to so park contrary to the rules established by the Town Council for the use of such lot or in any place or manner other than designated by the Council.

(C) *Hours.* It shall be unlawful to park any car or other vehicle in a municipal parking lot in the town between the hours of 3:00 a.m. and 7:00 a.m. unless the car or other vehicle is parked in a handicapped parking space in accordance with ' 72.06, or unless the car or other vehicle is parked within a designated area marked by appropriate pavement and/or curb stripping and the vehicle has a properly displayed parking permit obtained from the Clerk-Treasurer of the town.

(D) *Parking permits.* Any resident of the town who resides in the Downtown Zoning District, D-1, in a building or facility which does not have adequate off-street parking for its residents may obtain a parking permit from the Clerk-Treasurer, which permit, when properly displayed, shall permit the vehicle to be parked in the designated areas of the north parking lot and the south parking lot. The permit shall be displayed in a manner that makes it visible through the windshield of the vehicle. Parking permits may be issued on an annual basis or a monthly basis. Annual parking permits shall be valid from the date of issuance through December 31 of the year in which they are issued. Monthly permits shall be valid from the date of issuance through the last day of the month in which they are issued. The annual parking permit fee shall be \$25 and the monthly parking permit fee shall be \$5. Parking permit fees shall be waived for persons who reside in the Downtown Zoning District, D-1, on property which they own. Parking permits shall only be issued for vehicles in

operating condition which are duly licensed in the state.

The issuance of a parking permit by the town shall guarantee parking space availability. The use of the designated parking area shall be subject to such rules and regulations for snow removal, routine maintenance, and the like, as the Town Council may establish from time to time.

(C) Providing of proper painting and signage designating area.

(A) *No parking signs are posted or other notification of street cleaning, repairing, or resurfacing is made.* It shall be unlawful for any person to park, stand, or fail to remove a vehicle of any kind parked along any street, alley, or highway, when signs are posted or other written notification of intent to clean, repair, or resurface such street is made.

(B) *Notification.*

(1) Signs shall be posted in prominent places along any street, alley, or highway to be cleaned, repaired, or resurfaced at least 24 hours before the actual cleaning, repairing, or resurfacing;

(2) An officer who finds a vehicle parked on the street, alley, or highway shall attach in a permanent place a notice tag containing the following information:

(a) The date, time, officer's name, public agency, and address and telephone number to contact for information.

(b) The vehicle will be removed , if necessary, so as to not interfere with street cleaning, repairing, or resurfacing operations.

(c) The owner will be held responsible for all costs incidental to the removal.

(3) Written notification shall be provided to each residence along any street, alley, or highway to be cleaned, repaired, or resurfaced.

(C) *Exception.* This section shall not apply to or otherwise alter the provisions regarding parking regulations during snowfall found in Chapter 75, Sched. VII.

' 72.08 BLOCKING CROSSWALK PROHIBITED.

No vehicles, motor drawn or otherwise, shall be allowed to stand on any crosswalk in the town except so far as may be necessary in the crossing of the same, and any person being the owner, driver or person in charge or control of any such vehicle placed or suffered to stand on any such crosswalk in violation of the provisions of this section shall be punished as provided hereinafter.

The unpaid fines and the costs for towing and storing the vehicle must be paid in full before the vehicle is released. (Ord. 2009-05, passed 5-11-09)

The skateboard, if confiscated, shall be returned to the operator, or if the operator is under the age of 18, to the parent or legal guardian of the operator.

(2) *Subsequent offense.* Forfeiture of the skateboard, a fine of an amount set by Town Council and subject to amendment by Council from time to time, or both. The current fine amount is available for public inspection at the town offices during normal business hours.

' 76.01 DEFINITIONS.

For the purpose of this chapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

MOTOR VEHICLE. The meaning set forth in IC 9-13-2-105, except that **MOTOR VEHICLE** as used in this chapter shall not include a recreational vehicle as defined in IC 9-13-2-150 which is designed to transport more than ten passengers including the operator, or a chartered passenger motor vehicle licensed to operate within the State of Indiana.

ALCOHOLIC BEVERAGE. A liquid that:

- (1) Is, or contains, one-half percent (0.5%) or more of alcohol by volume;
- (2) Is fit for human consumption; and
- (3) Is reasonably likely, or intended, to be used as a beverage.

CONTAINER. A receptacle in which an alcoholic beverage is immediately contained and with which the alcoholic beverage contained in it is in immediate contact. (IC 7.1-1-3-13)

CHAPTER 77: POLICE DEPARTMENT FEES

(1) From a person applying for a four-year handgun license, a \$10 application fee, \$5 of which shall be refunded if the license is not issued.

(2) From a person applying for a lifetime handgun license who does not currently possess a valid Indiana handgun license, a \$50 application fee, \$30 of which shall be refunded if the license is not issued.

(3) From a person applying for a lifetime handgun license who currently possesses a valid Indiana handgun license, a \$40 application fee, \$30 of which shall be refunded if the license is not issued.

(4) The fees collected shall be deposited into the Firearms Training Fund, or other appropriate training fund, and used to train law enforcement officers in the proper use of firearms or other law enforcement duties, or to purchase firearms or firearm related equipment, or both for the law enforcement officers employed by the law enforcement agency.

(B) Accident photos: \$10 administrative service fee, plus:

(1) The actual cost incurred for reproducing each photo print;

(2) \$1 per laser print per photo.

(C) Fingerprinting: \$10 per fingerprint card.

(E) Vehicle inspection: \$5 per vehicle.

(B) Photocopies: \$.25 per 8 1/2" x 11" page for photocopies made on department copiers or printers; or the actual cost per page incurred by the department for reproductions made by an outside vendor.

' 77.04 ADMINISTRATIVE TOWING FEE.

(A) A \$20 administrative towing fee is hereby established and assessed against the owner of each vehicle towed by order of the Police Department to defray part of the administrative costs incurred for providing towing related services.

(B) The towing fee established under this section shall be collected by the Police Department prior to the issuance of any vehicle release pursuant to the procedures established by the Police Chief and approved by the Clerk-Treasurer.

(C) All administrative towing fees collected under this section shall be deposited by the Clerk-Treasurer into the local Police Education Fund for appropriation and expenditure pursuant to law.
