

ORDINANCE NO. 2022-14
AN ORDINANCE TO AMEND SEWER RATES AND CHARGES FOR
THE TOWN OF LOWELL WASTEWATER UTILITY

BE IT, AND IT IS HEREBY, ORDAINED by the Lowell Town Council as follows:

Section 1: Amendment of Sewer Rates and Charges. Section 51.075 of the Town of Lowell, Indiana Code of Ordinances shall be amended by deleting the existing metered rates and minimum charges for sewer service set forth in Subsections (C)(1) and (C)(2) of the Section and replacing them with the following:

Section 2: Conflicting Ordinances. Any Ordinance or provision of any Ordinance of the Town of Lowell or of the Town of Lowell, Indiana Code of Ordinances in conflict with the provisions of this Ordinance is hereby repealed.

Section 3: Severability. The invalidity of any section, clause, sentence, or provision of this Ordinance shall not affect the validity of any other part of this Ordinance which can be given effect without such invalid part or parts.

Section 4: Effective Date. This Ordinance shall be in full force and effect upon its passage, approval by the Executive and publication as required by law, whichever is later.
