PARK RULES and GUIDELINES

No refunds issued.

No motorized vehicles on park property.

Please no skateboards, roller blades or bikes on the playground equipment or basketball courts.

Park hours are dawn to dusk.

No alcohol permitted on Park Property.

Cooking fires are permitted, provided such fires are contained in park or privately owned grill.

Inflatable bounce houses or slides are not permitted.

The use of confetti, water balloons and silly string are prohibited.

No pets in parks (service animals are always permitted)

Disturbing the peace, loudness, fighting, riotous tumult, profanity and abusive language are not tolerated in the parks.

No swimming, bathing or wading shall be permitted in any body of water within the park.

Fishing in Evergreen Pond is available. Compliance with all State Fish and Game regulations is required. Please observe catch limits and restrictions which are posted within the park.

Please bring your receipt with you to your event. This will help to clarify that you are the person who has rights to the shelter on your reserved date. If assistance is needed, we ask that you contact the Lowell Police Department to manage the situation. The receipt will show that you are the rightful renter.

If you need assistance on the weekend, we ask that you message The Lowell Parks Department Facebook page through messenger. All other concerns will be addressed on the next business day.
