Chief Woestman informed the Commissioners that the town has approved a feasibility study for a new range and training center that would potentially be built alongside the new town maintenance facility and they are meeting with the firm next week to begin the process.

Chief Woestman stated the police department will partner with the Lowell Fire Department for an open house on October 13th.



XI. ADJOURNMENT


Commissioner Sanfratello made a motion to adjourn the meeting, seconded by Commissioner Borchert. 4 ayes, motion passed.
